- 1. This form is used to apply for approval of the sale and purchase of prohibited parts by mail order or on the internet.
- 2. In addition, where purchasing by mail order or on the Internet, the item must be delivered by the courier as agreed or specified by Police.
- 3. You may not take possession of any prohibited part unless you have:
 - 1. a current firearms or dealer licence, and
 - 2. a current prohibited firearms endorsement appropriate to the item being purchased.
