

Dealer Employee Application Form

This application form is for all applicants for an endorsement to a New Zealand Firearms Licence in their capacity as an employee of a licensed dealer so that they can handle pistols, restricted weapons, prohibited firearms, and/or prohibited magazines possessed by their employer in the course of their employment.

You do not need an endorsement if your work activities do not include pistols, pistol carbine conversion kits, restricted weapons or prohibited items.

Note: Holders of this endorsement may only handle their employer's arms items while at work. This endorsement does not allow them to apply for a permit to possess any pistols, restricted weapons, prohibited firearms, and/or prohibited magazines, or pistol carbine conversion kits (see s35(2A), s35AAA(2)(b), s35A(2A), Arms Act 1983).

This application form is for those who are:

- An existing firearms licence holder who wishes to work as an employee of a licensed firearms dealer and in the course of their duties needs to be able to handle pistols, restricted weapons, prohibited firearms, and/or prohibited magazines; OR
- 2. Applying for a New Zealand Firearms Licence for the first time AND a dealer employee endorsement at the same time; OR
- 3. Reapplying for their New Zealand Firearms Licence and wish to also:
 - a. reapply for their existing dealer employee endorsement; OR
 - b. apply for a dealer employee endorsement for the first time

Important note:

- 1. Where you are a current licence holder and are applying for this endorsement for the first time, your application must contain both:
 - This endorsement application form; AND
 - A firearms licence application (FRM23FLA) with only sections A, F, G, L and N completed.
- 2. In all other cases, your application must contain both:
 - This endorsement application form; AND
 - A firearms licence application form completed in full to ensure Police has the latest information about you and your circumstances.

When applying for two or more endorsements at the same time only submit one application for a firearms licence.

Who can apply

To apply for a firearms licence endorsement you need to meet the following criteria:

- » You are sixteen years of age if applying for an endorsement to possess pistols and restricted weapons as the employee of a registered dealer; OR
- » You are at least eighteen years of age or older if applying for an endorsement to possess prohibited firearms and prohibited magazines as the employee of a registered dealer; AND
- » You must hold a current New Zealand Firearms Licence, or be applying for a Firearms Licence.

What you need to do

Did you know you can now complete your application online at MyFirearms? MyFirearms is our new secure online portal where you can apply and pay for your licensing and most endorsements online. Please ensure you read the following carefully before you begin your application for a firearms licence. An incomplete form will cause delays in processing your application.

1. Complete the endorsement application form

Download the endorsement application form to your computer or device. Enter the information requested and save the form.

Important note: Please save the form to your device and open it using your PDF software. We recommend using <u>Adobe</u> <u>Acrobat Reader</u>. If the form is completed using a browser, the entered information may be lost if you click on the 'back' button or if you try to save it.

Print out and sign the completed endorsement application form, or print out a blank form and handwrite your responses.

2. Complete the firearms licence application form as appropriate

Download the firearms licence application form to your computer or device.

- Where you are a current licence holder and are applying for this endorsement for the first time, complete only sections A, F, G, L and N.
- In all other cases you must complete the firearms licence application in full.

Important note: Please save the form to your device and open it using your PDF software. We recommend using <u>Adobe Acrobat</u>. <u>Reader</u>. If the form is completed using a browser, the entered information may be lost if you click on the 'back' button or if you try to save it.

Print out and sign the completed firearms licence application form, or print out a blank form and handwrite your responses.

3. Pay the fee

Pay the non-refundable endorsement application fee at a New Zealand PostShop and keep a receipt to include with your application.

NOTE: If you already have a current firearms licence you don't need to pay another firearms licence application fee.

4. Get the required documents

To submit a printed application form at a Police station you'll need to include:

- a copy of the PostShop receipt of your application fee
- the completed endorsement application form
- a completed firearms licence application form

5. Submit your applications to Police

Submit your printed application at your nearest *Police station* or post it to Kapiti Digital Services Centre, PO Box 722, Paraparaumu 5032.

What you will need to apply

For your application to be considered, you will need to:

- » meet the endorsement eligibility criteria, and
- » have employment evidence from your current employer

In your endorsement application, you will need to be able to:

» supply the name and contact details for an endorsement related referee who will be interviewed by Police as to your suitability to possess firearms in your position as an employee working for a firearms dealer.

What happens next

Once your application has been received, Police will perform further checks in order to assess whether you are suitable to possess pistols, restricted weapons, prohibited firearms and/or prohibited magazines.

NOTE: Applying for or renewing a firearms licence or an endorsement is an activating circumstance. If this is your first activating circumstance, you are required to register all firearms in your personal possession, or declare you possess no firearms, within 30 days. You can do this online in MyFirearms or calling the Registry and Services Team on 0800 844 431.
