

This guide aims to provide an accessible overview of the best practices for the safe possession, management, and appropriate storage and display of firearms and arms items within a museum setting.

# Investing in quality equipment for firearms safety courses

Having realistic, good quality equipment for trainers and trainees helps us get the best possible learning outcomes.

Te Tari Pūreke have upgraded the fleet of deactivated rifles used in the 500+ firearms safety courses run every year.

The new, robust .223 calibre rifles have replaced the various different .22 rimfire bolt action rifles which have reached the end of their service life and the new rifles will definitely improve the practical handling portion of the safety course. The new centrefire bolt action rifles now allow the use of training rounds which will also improve the training experience for the students.

The variety of firearms used in the training are now more aligned with what trainees might use, as a firearms licence holder.

#### **Firearms Registry**

We have had more than 137,051 firearms registered since the Registry has been live.

Remember, the first time you have an activating circumstance you are required to record all arms items in your possession.

#### Firearm licensing performance

Te Tari Pūreke is working to complete all firearms licence applications within three months (90 days).

However, it should be recognised that in some situations it will take longer than three months to arrange with applicants and complete parts of the process. For example, in-person interview, interviewing referees, and inspecting an applicant's storage facilities.
