

### **Updated Storage and Transportation Guide for 2025**

We have made a number of changes to our secure storage and transportation guide for firearms and ammunition.

The changes are designed to make the guidance easier to understand, interpret and apply, for both firearms licence holders and our vetters.

Some sections have been strengthened or clarified (such as clarity on the construction of commercially built steel safes and options for ammunition storage), and new sections have been added (such as guidance on where to store keys and using heavy bank safes or shipping containers for firearms storage).

# June 2025 obligations | ammunition sales

This is a reminder that licence holders may now have an activating circumstance when they purchase ammunition from firearms dealers and ammunition sellers – if they have not had one already.

Licence holders who already held a licence on 24 June 2023 (when Firearms Registry regulations took effect), and who have not yet registered their firearms into the Firearms Registry, will need to register all the firearms and arms items in their possession within 30 days of purchasing ammunition from a retailer. The purchase of ammunition from another licence holder is not an activating event.

### Prohibited tubular magazines and .22 calibre rifles

Te Tari Pūreke – Firearms Safety Authority has made a policy change for high-capacity non-detachable (tubular) prohibited magazines, which affects some rimfire .22 calibre rifles – including lever, bolt or pump action.

From June 2025, firearms licence holders who have registered these firearms may be given the option to modify the prohibited tubular magazines – those holding more than 10 rounds – that may allow these firearms to be retained as a non-prohibited item.

The only pathway to remedy the non-compliant firearm is through registration in the Firearms

Registry.

After the .22 has been registered, the licence holder will be contacted by Te Tari Pūreke Compliance Team who will work with the licence holder on what options are available to them, including modification by a qualified gunsmith.



### Revised firearms safety tests now in use

We have taken on board feedback from firearms safety trainers and stakeholders regarding the tests used for our firearms safety training.

A new format has now been introduced and licence applicants can look forward to seeing:

- Multiple-choice questions so licence applicants can tick their answer of choice and revise an answer if they need to. We've replaced the old foil scratch-off sheets.
- Test instructions and question papers that are easier to read.
- Questions that are easier to comprehend (but not easier to pass).

On our website we proactively release firearms regulatory information to help people better understand features of the licence holder community, and aspects of the performance of New Zealand's firearms regulatory framework. We have provided a snapshot of this data below.
