

# Notice of a Temporary Non-Pistol Shooting Range Section 38XD, Arms Act 1983 (the Act)

#### **Privacy Statement**

The information provided is collected for the purpose of administration of the Act. New Zealand Police will hold, store, use or disclose the personal information collected in accordance with the provisions of the Privacy Act 2020. This means that, where necessary, Police may use or disclose your personal information to enable it to carry out its lawful functions, including prevention, detection, investigation and prosecution of offences. Notice to the Commissioner under section 38XD of the Act of a temporary non-pistol shooting range must be given by the operator at least one (1) week prior to the beginning of the shooting event for which the temporary non-pistol shooting range is to be set up. Pistol shooting may not be conducted on a temporary non-pistol range.
