Police action on unlawful hunting

Over the winter months Police have been active throughout New Zealand targeting areas known for unlawful hunting activity.

Police in the rural areas of Wairarapa,
Hawkes Bay, East Coast, West Coast and
Southland have encountered a number
of offenders, resulting in charges and
warnings to hunters acting unlawfully.

Hunters are reminded that they always need permission to hunt on any land, and you must follow the transportation rules every time you are on the road with your firearms. Do it right every time, you never know when Police may be active in your local area.

Firearms diversion

The diversion of firearms to the black market was the focus of a joint Police and Firearms Safety Authority operation in Bay of Plenty and Gisborne during August. Four men have been charged and a firearms dealer has had his licence suspended, pending revocation.

The Authority's Executive Director Angela Brazier said: "We know from the recent review of the Firearms Registry that firearms diversion from licence holders to the black market remains a threat to public safety. The majority of firearms licence holders are good law-abiding people, unfortunately there are still a few who divert firearms to unlicensed offenders." Read more.

Our monthly Firearms Registry Update shows we have reached a notable milestone. The total number of licence holders who have entered details in the Registry has passed the 100,000 mark.

A sizeable proportion, more than 30 percent of those who have registered, did so proactively without waiting for an activating circumstance.

We acknowledge everyone who has completed the Registry so far and are doing their bit to make it harder for unlicensed people to access firearms.

Shooting under immediate supervision

Many firearms licence holders like to take new people out with them to introduce them to hunting or shooting but remember anyone who possesses or uses a firearm needs to have a firearms licence unless they are under the immediate supervision of a licence holder.

Shooting under the supervision of an experienced licence holder is how most people first learn how to safely use a firearm, before they apply for their own licence.

Immediate supervision means that the licence holder is:

- physically present and actively supervising the shooter
- close enough to be able to take control of the firearm being used by the shooter if necessary, and
- not using another firearm while providing supervision.
