

# Broadcaster/Theatrical endorsement

# **Application Form**

This application form is for use by all applicants for a broadcaster/theatrical endorsement on a New Zealand Firearms Licence. This is an endorsement for a broadcasting/theatrical employee/member to allow the possession of pistols, restricted weapons, prohibited firearms and/or prohibited magazines (as relevant) for the purposes of the production of stage shows, films or television programmes, and re-enactment of historic and ceremonial events.

Applicants may apply for this endorsement, subject to either or both of the following conditions, depending on their situation:

- 1. The endorsement holder may act as an on-site theatrical armourer or assistant to a theatrical armourer, and supervise the use of any firearms, prohibited items, and restricted weapons (for which they have an endorsement) for the purposes of making a broadcast or a theatrical, cinematic, television film, or video production if a dealer has hired out those items in accordance with section 5C of the Act.
- 2. The licence holder may, as an approved employee or approved member of a broadcaster or a bona fide theatre company or society, or a cinematic or television film production company, or a video recording production company, possess pistols, restricted weapons, and prohibited items and use those items in commemorative or historical re-enactment events, but (unless permitted by subclause (2)) must not act as an on-site armourer for the purposes of section 5C(2) or 7(4) of the Act.

This application form is for those who are:

- 1. An existing firearms licence holder who wishes to apply for this endorsement; OR
- 2. Applying for a New Zealand Firearms Licence for the first time AND also wish to apply at the same time for this endorsement; OR
- Reapplying for their New Zealand Firearms Licence and wish to also: reapply for this endorsement; OR
  - apply for this endorsement for the first time.

# Important notes

- 1. Where you are in group 1 above your application should contain both:
  - This endorsement application form; AND
  - A firearms licence application (FRM23FLA) with only sections A, E, F, G, L and N completed, to ensure Police has the latest information about you and your circumstances.

- 2. In all other cases (groups 2 & 3 above), your application must contain both:
  - This endorsement application form; AND
  - A firearms licence application form completed in full

When applying for two or more endorsements at the same time only submit one firearms licence application form.

3. You will need to provide confirmation in writing that you are an approved employee or approved member of the broadcaster; or bona fide theatre company or society; or cinematic or TV film production company; or video recording company under s29(2)(e) and/or 4A(1)(e). This document should be signed by the chief executive officer of the body by which you are employed by or of which you are a member (s29(3)).

# Who can apply

To apply for an endorsement to your firearms licence you need to meet the following criteria:

- » You are sixteen years of age or older if applying for endorsement to possess pistols and/or restricted weapons, OR
- » You are eighteen years of age or older if applying for endorsement to possess prohibited firearms and/or prohibited magazines; and
- » You must hold a current New Zealand Firearms Licence, or be applying for a Firearms Licence.

NOTE: To hire out any arms items, including pistols, restricted weapons, prohibited firearms and/or prohibited magazines to production companies or broadcasters in the way of business, you must hold a current dealer's licence.

# What you need to do

# 1. Complete the endorsement application form

Download the endorsement application form to your computer or device. Enter the information requested and save the form.

**Important note:** Please save the form to your device and open it using your PDF software. We recommend using <u>Adobe</u> <u>Acrobat Reader</u>. If the form is completed using a browser, the entered information may be lost if you click on the 'back' button or if you try to save it.

Print out and sign the completed endorsement application form, or print out a blank form and handwrite your responses.

# 2. Complete the firearms licence application form as appropriate

Download the firearms licence application form to your computer or device.

- Where you are a current licence holder and are applying for this endorsement for the first time, complete only sections A, E, F,
   G. L and N.
- In all other cases you must complete the firearms licence application in full.

**Important note:** Please save the form to your device and open it using your PDF software. We recommend using <u>Adobe</u>

<u>Acrobat Reader</u>. If the form is completed using a browser, the entered information may be lost if you click on the 'back' button or if you try to save it.

Print out and sign the completed firearms licence application form, or print out a blank form and handwrite your responses.

# 3. Pay the fee

Pay the non-refundable endorsement application fee at a New Zealand PostShop and keep a receipt to include with your application.

NOTE: If you already have a current firearms licence you don't need to pay another firearms licence application fee.

## 4. Get the required documents

To submit a printed application form at a Police station you'll need to include:

- · a copy of the PostShop receipt of your application fee
- the completed endorsement application form
- a completed firearms licence application form

## 5. Submit your applications to Police

Submit your printed application and supporting documents to Police at your local Police station or by courier post to National Support Team, Te Tari Pūreke, Level 3, 210 Federal Street, Auckland 1010, New Zealand.

# What you will need to apply

For your application to be considered, you will need to:

- » meet the endorsement eligibility criteria, and
- » have endorsement-specific firearms storage facilities, and
- » a vital part storage location if you are intending to possess prohibited firearms.

In your endorsement application, you will need to be able to supply the name and contact details for an endorsement-related referee who will be interviewed by Police as to your suitability to possess and maintain firearms, pistols, restricted weapons, prohibited firearms and/or prohibited magazines (as relevant).

# What happens next

Once your application has been received, Police will perform further checks in order to assess whether you are suitable to possess the relevant arms items in this capacity.

Police will ask your referee to fill out a questionnaire and then interview them.

You will need to:

- » attend an in-person interview with Police to discuss your application and determine that you are suitable to possess pistols, restricted weapons, prohibited firearms and/or prohibited magazines (as relevant) for the purpose of the production of stage shows, films or television programmes, or participation in historical re-enactments.
- » show your endorsement-specific firearms storage facilities, and
- » show your vital part storage location if you are intending to possess prohibited firearms.

**NOTE:** Applying for or renewing a firearms licence or an endorsement is an activating circumstance. If this is your first activating circumstance, you are required to register all firearms in your personal possession within 30 days. You can register online in MyFirearms or by calling the Registry and Services Team on 0800 844 431. Find out more about the Registry at *firearmssafetyauthority.govt.nz/registry*.

They must have a good knowledge of your participation in the activities covered by the endorsement application, and knowledge of your engagement in this/these activity/ies.

They should be a person who is a firearms dealer (hire business), or involved in a senior capacity in a theatrical or film production company or professional association/society and who knows you well. Ideally your referee holds a broadcaster/theatrical endorsement as well and understands the role and the responsibilities of a theatrical armourer.

Your broadcasting or theatrical organisation referee:

- cannot be your current spouse or partner, or an otherwise related person.
- must be at least 20 years old.
