

Notification of Change of Address Form

Arms Act 1983, Section 34

- 1. A holder of a firearms licence who changes their address must, within 30 days after doing so, give written notice of the change to Police.
- 2. Did you know you can now update your contact and address details online at MyFirearms? Visit www.firearmssafetyauthority.govt.nz to find out more.
- 3. If you hold an endorsement(s) on your firearms licence and are intending to change address, you need to notify Police **in advance** about what arrangements you have made for the safe custody of any pistol, prohibited item, prohibited magazine, or restricted weapon during it's shift to the new address.
- 4. You can also use this form to update Police with any other changes to your contact details.
- 5. Once completed, submit this form to <u>firearms.NST@police.govt.nz</u>, or submit it to Police at your local Police station or by courier post to National Support Team, Te Tari Püreke, Level 3, 210 Federal Street, Auckland 1010, New Zealand.
