



FIREARMS LICENCE SURRENDER FORM

Complete this form if you are a firearms licence holder who wishes to surrender (give up) their firearms licence before it expires.

If you surrender your licence, you will no longer be licensed to possess any arms items or ammunition. You must sell or otherwise dispose of your arms items and ammunition before surrendering your licence. This also applies to Power of Attorney.

- The power of attorney has taken effect. If it only takes effect in the event that the person is mentally incapable, ensure you have also received (and taken a copy of) a medical certificate stating that the person is mentally incapable.
